- 7.3.2 In case of unjustified and unacceptable delay in execution of the assigned work as per timelines given at sub-para 7.3.1, a penalty of 1.0% of the work order value per week will be levied.
- 7.3.3 Time taken by the Ministry of Steel for evaluating the quality and conformity of deliverables as per "Scope of Work" will not be treated delay on the part of the Agency.
- 7.3.4 In case Ministry of Steel suggests some changes or value additions beyond the normal scope of the work, a reasonable additional time will be provided and the vendor will not penalized for the additional time required to execute the project. However, if the vendor fails to provide all required deliverables as per the scope of work at the stage of submission of draft report/final report, such delays will attract penalty as stipulated at sub-para 7.3.2.
